- a. Our Strategic Plan document was developed June 2018 by a committee of CSCO members and partners; will report annually on the plan;
- b. ACBO we presented to ACBO October 3, 2019; focus of presentation was how Chaplaincy Leaders seek to serve their school communities using the framework of the ACBO Renewing the Promise document.



- c. OCSTA We hope to have a booth at the Ontario Catholic School Trustees Association (OCSTA) conference in April 2019.
- d. CPCO Jolene Smith represented CSCO at the CPCO Conference November 2019;
- ICE Jolene Smith connected with Michael Pautler, Executive Director of the
 Institute for Catholic Education (ICE) at the CCC Faith in Education Plenary in

 November 2018 and at the Adult Faith Formation Conference in February 2019.
- f.
